

### Trash Pick-Up Dates -

Trash Day is Wednesday. If there is a holiday Monday, Tuesday, on Thursday, or Friday, then Trash Day is still on Wednesday. If the holiday is on or placed in either drop box. ### Storm Sirens —

Just a reminder, we will continue to test the storm sirens on the second Wednesday of the month at 10:00 a.m. If you doubt one of the storm sirens is working properly please notify City Hall at (417) 623-2027.

Our sirens are for outdoor warning. If you are indoors you need to rely on television or a NOAA weather radio. The sirens will sound when a tornado warning is received for our portion of our county or surrounding counties or when winds speeds reach 70 MPH or higher. We will not issue an all clear.

The city residents have access to the storm shelter owned at the Beacon Safe Room. (Duenweg Elementary school) located at 202 Malloy Circle. The fire station is not a shelter. If you go to the fire station you will be sent to the shelter at the school. The shelter will be opened when severe weather approaches our area. The school district has a policy that any animal in the shelter must be in a cage

This article was originally published in the "Sarcoxie Record" on 6/16/1976. It is presented here in a 5 part section of this and upcoming newsletters. No changes have been made as to wording or phrases. We hope our readers enjoy this "Introduction to Duenweg."

### Part 5

Also in the area, on November 29, 1863 Captain Milton Burch, of the Eighth Missouri Calvary, United States Volunteers stationed at Neosho with a detachment of men, made a scouting expedition into Jasper County for the purpose of capturing a number of southern sympathizers who were members of a Confederate group of scouts home on furlough. The party scouted along from the head of Turkey Creek (the area east of Prigmor Road and south of 20th Street) to the wester limits of the county. They went from house to house where the Confederate soldiers lived, surprised and captured them in their beds. Six southern men were captured and two were killed in this scouting.

In the late 1860's there was a lot of reorganization and reconstruction to be done in Jasper County and it took a lot of good people willing to work to put things back together again.

One of the first noted families, to settle in the area of where the town of Duenweg is located today, were the Webb's. First two brothers left their home in Overton County Tennessee and settled to the west of Duenweg and most of the land on which the present day Duenweg is setting belonged to Wiley W. Webb and his heirs.

Next month we hope to begin our story with these two brothers, Elijah C. Webb and James C. Webb and their families and tell what a big part they played in the development of Duenweg and the rebuilding of this part of Jasper County.
