• Center Creek board discussion. Mayor Olds informed the Board of Aldermen regarding possibly joining the Center Creek Wastewater Treatment Facility Board and inclusion of a seat on the Center Creek Board. In the preliminary investigation the City of Duenweg would build approximately 1.5 miles of gravity line and approximately 7 miles of pressure line with an aerator station somewhere in the middle. Preliminary discussion has also indicated this could cost anywhere from \$4.5 to \$5.0 million, with the possibility of receiving grant monies. Mayor Olds asked 2 questions of the Board of Aldermen: 1) Does the council wish us to pursue in this endeavor? 2) Can we retain Andy Simmons of Simmons Engineering as a consultant for the progress of the project?
